

William R. Simms Award for Outstanding Youth in Philanthropy Group

William R. Simms was one of the four founders of AFP and had a long-standing interest in engaging young people in philanthropy. This award, named in his honor, recognizes service by a group of young people ages 10–23 who demonstrate outstanding commitment to the community through direct financial support, development of charitable programs, volunteering and leadership in philanthropy. Nominees will be judged based on work done while they were 10–23 years old. Nominations will be considered based on the responses to the following criteria:

- a. Description in detail of what the nominees did, including goals, process, budget (if relevant) and other people involved in the process (adult leaders or adviser, etc.) and of the time, talent and/or
- b. Description of the impact the nominees had on the community, including numbers of people involved, financial impact, organizations helped, etc. Please include the names and contact information of individuals at the organizations who benefited from the nominees work. (0-30 points)
- c. Long term (3-5 years) impact of the nominees work. Will the project(s) be ongoing and have the nominees considered next steps or are working on other projects? (0-20 points)
- d. Evidence that the project(s) can serve as a prototype for others or is easily replicable in other communities. (0-10 points)
